1. The **GP Koirala National Center for Respiratory Diseases, Dulegauda** invites *electronic* bids from eligible bidders for the procurement of **Medicine Items at Hospital Pharmacy** under National competitive bidding – Single Stage Single Envelope procedures.

3. Bidder have the option of submitting their bid electronically only. Submission of hard copy bid shall not be entertained. Bidder can download the bidding document for e- submission from PPMO's web site www.bolpatra.gov.np/egp.. Bidders, submitting their bid electronically, should deposit the cost of bidding document 5000/- in the following Rajaswa (revenue) account as specified below .

4. Pre-bid meeting shall be held at **GP Koirala National Center for Respiratory Diseases, Dulegauda** at **2083/03/22 1:00 pm**
5. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before ***www.bolpatra.gov.np/egp on or before 12:00 pm on 2083/04/04***. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at ***2:00 pm on 2083/04/04*** at the office of GP Koirala National Center for Respiratory Diseases Dulegauda, Tanahu. Bids must be valid for a period of ***90 days*** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. ***1344500/-*** [one million three hundred forty-four thousand five hundred.], which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a **public holiday¹** applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.

¹ In case of electronic bid invitation, purchaser shall extend the deadline as required in the e-GP system.
