3. Bidder have the option of submitting their bid electronically only. Submission of hard copy bid shall not be entertained. Bidder can download the bidding document for e- submission from PPMO's web site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).. Bidders, submitting their bid electronically, should deposit the cost of 3000/- . bidding document in the following Rajaswa (revenue) account as specified below .

4. Pre-bid meeting shall be held at **GP Koirala National Center for Respiratory Diseases, Dulegauda** at **2083/03/23 1:00 pm**
5. Electronic bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 pm** on **2083/ 03/32**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 2083/03/32** at the office of GP Koirala National Center for Respiratory Diseases Dulegauda, Tanahu. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **105500/-.[One Hundred And Five Thousand Five Hundred Only.]**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a **public holiday<sup>1</sup>** applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
